- National Survey for Student Engagement (NSSE): Revisited comments from the NSSE, a survey administered to graduating seniors, that indicate overall student dissatisfaction with Discovery requirements. The comments often mentioned that the requirements are not flexible enough and felt like an obstacle. Major changes to Discovery are on hold while we wait for other issues to be resolved but there is a desire to improve the student experience. Discussion ensued regarding potentially making small, incremental changes that could streamline the program to provide more flexibility to students while keeping in mind there may be a major overhaul in the future.
